Over night parking is limited to fully self-contained vehicles.
RV/Camper must have sewer, water tank and electrical capabilities.
Sleeping in vans, tents, cars or cargo trailers prohibited.

We ask that reservations be made as soon as possible due to the limited amount of space we have to accommodate RV/Campers. Refunds will be made if cancellation is made within 48 hours of your event. Arrival is limited to 2 days prior to the event and check out is no longer than 2 days after the event. **We ask that you check-in with the office upon arrival, even though you have reservations.** Office hours are Monday thru Friday 8am - 4:30pm. The South Carolina State Fair assumes **NO RESPONSIBILITIES** for damages, theft or injuries while using the site or facilities. **There is a 10% surcharge for a cancellation.** Please remember that space is available on a first-come basis. Our full hookups are limited in the area we use for RV/Campers. ***There is a chance you may not receive hookups.***

SHOWS - RV/CAMPER PARKING RULES AND REGULATIONS

SLEEPING PROHIBITED IN VEHICLES THAT ARE NOT EQUIPPED WITH WATER, ELECTRICAL OR SEWER CONNECTIONS, SUCH AS VAN, CARS, TRUCKS, TENTS OR CARGO TRAILERS

- PARKING IS ON A FIRST-COME BASIS AS WE ARE VERY LIMITED IN THE NUMBER OF HOOKUPS IN THE AREA RESERVED FOR RV/CAMPERS. YOU MAY OR MAY NOT RECEIVE HOOKUPS.
- FEES ARE CHARGED WHEN YOU ENTER THE FAIRGROUNDS, REGARDLESS OF HOOKUP OR OCCUPANCY.
- CAMP FIRES ARE TO BE CONTAINED IN CONTAINERS DEVELOPED FOR SAME. COOKING GRILLS ARE PERMITTED. WE ASK THAT YOU DO NOT PLACE CHARCOAL ON ASPHALT AREAS AND THAT YOUR FIRES ARE COMPLETELY EXTINGUISHED, **NEVER LEAVE A FIRE UNATTENDED.**
- DO NOT PARK IN ANY AREA OF ROADWAYS MARKED "NO PARKING" OR "FIRE LANES". VIOLATORS WILL HAVE THEIR VEHICLES TOWED AT OWNERS EXPENSE.
- PETS ARE ALLOWED, BUT MUST BE KEPT ON A LEASH OR IN A SECURED PEN AT ALL TIMES. **PLEASE CLEAN UP AFTER YOUR PET.**
- THE SELLING OF GOODS OR SOLICITING IS PROHIBITED ON FAIR GROUNDS PROPERTY. THIS DOES NOT INCLUDE THE AREA YOU HAVE RENTED FROM THE PROMOTER OF THE SHOW.
- PLEASE ASSIST US IN KEEPING THE GROUNDS CLEAN. IF YOU NEED EXTRA TRASH RECEPTACLES, PLEASE LET US KNOW AT THE OFFICE.
- WE HAVE LOTS OF BURIED PIPES WITH WATER, ELECTRIC AND SEWER IN MANY AREAS OF THE FAIRGROUNDS. THEREFORE, METAL DETECTORS ARE PROHIBITED FROM BEING USED ON OUR PROPERTY.
- THE POSTING OR SOLICITING OF HAND BILLS ON VEHICLES OR OTHER PARTS OF THE FAIRGROUNDS IS PROHIBITED BY SOUTH CAROLINA LAW.
- **THE USE OF A GENERATOR REQUIRES A STACK.**
- WE RESERVE THE RIGHT TO REVOKE ANY PERMIT FOR FAILURE TO ABIDE BY THESE RULES AND REGULATIONS OR OF THE SOUTH CAROLINA DEPARTMENT OF HEALTH AND ENVIRONMENTAL CONTROL. IF A PERMIT IS REVOKED, NO REFUNDS WILL BE ISSUED AND YOU MUST VACATE THE PROPERTY IMMEDIATELY. PURSUANT TO 16-11-600 OF THE SOUTH CAROLINA CODE OF LAWS.
