### **Promotional/Giveaway Terms & Conditions**

Your participation in the South Carolina State Fair’s Giveaway (“The Giveaway” or “Promotion”) shall be deemed to be your complete acceptance of the terms and conditions herein. The following are the Terms and Conditions of the Giveaway, which is sponsored by the South Carolina State Fair (S. C. State Fair).

**NO PURCHASE NECESSARY.** A purchase will not increase your chances of winning.

**ELIGIBILITY:** The South Carolina State Fair Family Fun Pack VIP Day at the Fair is open to all current legal residents of South Carolina in the United States who are at least 18 years old at the start of the contest (“Entrants”). The Sweepstakes is sponsored by the South Carolina State Fair, 1200 Rosewood Ave, Columbia, SC 29201 (“Sponsor”). Void where prohibited by operations of law. Employees, shareholders, officers, directors, agents, representatives of Sponsor (“Prize Provider”) and the promotion and advertising agencies of any aforementioned entity (“Sweepstakes Entities”), and their immediate family members (defined as spouse, mother, father, sisters, brothers, sons, daughters, uncles, aunts, nephews, nieces, grandparents and in-laws, regardless of where they live) and those living in their household (whether related or not), and each person or entity connected with the production or administration of the Sweepstakes, and each parent company, affiliate, subsidiary, agent and representative of any aforementioned entity are not eligible.

**SWEEPSTAKES PERIOD:** The Sweepstakes begins at 12:01 a.m. EDT on Tuesday, Sept. 12, 2023, and ends at 11:59 p.m. EDT on Tuesday, Oct. 10, 2023 (Sweepstakes Period). During the Sweepstakes Period, Sponsor will conduct one (1) sweepstakes with four (4) prize winners, and all entries must be submitted by 11:59 p.m. EDT on Tuesday, Oct. 10, 2023.

**HOW TO ENTER:** Beginning at 12:01 a.m. EDT on Tuesday, Sept. 12, 2023, an entry is defined as an eligible person (defined above) that makes an online purchase at [scstatefair.org](http://scstatefair.org) with Etix of a Family Fun Pack for the 2023 S.C. State Fair during the sweepstakes period. In addition, an entrant may mail in or hand-deliver a postcard that is postmarked and/or delivered during the sweepstakes period. Postcards must be delivered during the sweepstakes period to: The South Carolina State Fair Dowling Building, Family Fun Pack VIP Day at the Fair, 1200 Rosewood Dr., Columbia, SC 29201. The postcard must be handwritten, legible and include the entrant's full name, email address, and phone number.

Sponsor is not responsible for late, damaged, delayed, destroyed, misdirected, incomplete, illegible, corrupted, or mutilated entries. If a credit card is denied, entry is ineligible. Only one postcard per entrant name is eligible. Sponsor reserves the right to disqualify false entries or entries suspected of being false. Entries generated by a script, macro or other automated means will be disqualified. In the event of a dispute as to the identity of a Selected Entrant, as defined below, the Selected Entrant will be deemed to be the person whose name is on the purchase of the family fun pack through Etix or whose name appears first on the postcard. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

**NOTIFICATION:** Each qualified Entry received during the Sweepstakes Period will be considered to win the Prize, defined below, consideration will take place on or about Wed., Oct. 11, 2023 ("Judging Date"). On the judging date, Sponsor will consider all qualified entries received by the Deadline to determine four (4) potential winners ("Selected Entrants") from combined family fun pack purchases and postcard entries. The winners are randomly selected from eligible entrants. The objective of the contest is to promote excitement and enthusiasm towards the South Carolina State Fair and Carolina Lights events. ("Objective") The Selected Entrant will be notified by email. The Selected Entrant will be required to respond (as directed) within 24 hours of attempted notification. The failure to respond timely to the notification may result in forfeiture of the prize and, in such case, Sponsor may select an alternate chosen Entrant from among the remaining eligible entries. The Selected Entrant may also be sent an affidavit of eligibility/liability/publicity release ("Release"). Except where prohibited by law, Selected Entrant must allow Sponsor to use his/her name, likeness, and hometown for marketing purposes. The Selected Entrants' name may be published in any media publications including print, radio, television, websites and/or social media pages in the form of social media name, first name, last name and hometown and the video submission. Unless restricted by law, the Selected Entrant will be required to complete

and return the Release within the time period specified therein. An alternate Selected Entrant may be randomly selected from among the remaining eligible entries if a Selected Entrant: (i) cannot be reached; (ii) fails to obtain all signatures on the Release and to return the documents in a timely manner as required pursuant to these Official Rules; or (iii) cannot accept or receive the prize for any reason. Assumed notification by email messages does not constitute a winner. Sponsor will not make multiple attempts to contact Selected Entrants.

ODDS: Odds of winning depend on the total number of eligible entries received.

PRIZES: If eligible under these rules, four (4) Selected Entrants will receive:

- 4 VIP CIRCUS at the Fair passes (valued at \$200)
- 1 behind-the-scenes circus tour for your group of 4. (valued at \$100)
- \$50 in food vouchers
- 2 fast pass tickets, to gain front of the line ride privileges (valued at \$40)

Each prize is valued at a total of \$390, from the S.C. State Fair. Any taxes and any other costs not specifically stated within these Official Rules – including but not limited to licensing and registration fees, travel to Sponsor’s location to obtain the Prize, and any taxes – are the sole responsibility of the Selected Entrant. Selected Entrant is not permitted to substitute the Prize. Prizes are nontransferable and nonredeemable for cash. The ARV of any prize is subject to price fluctuations in the consumer marketplace based on, among other things, any gap in time between the date the ARV is estimated for purposes of these Official Rules and the date the prize is awarded or redeemed. Selected Entrant is not entitled to any surplus between actual retail value of prize and stated ARV and any difference between stated ARV and actual value of the prize will not be awarded. No substitution, transfer, or cash redemption of prize, provided however that Sponsor or Prize Provider reserves the right to substitute the prize with another prize of equal or greater value should the advertised prize become unavailable for any reason. Selected Entrant is solely responsible for all federal, state, and local taxes on the Prize and other unspecified expenses related to the Prize. All activities related to the Prize are at the Selected Entrant's own risk and subject to whatever restrictions are imposed by the entities that govern activities.

- VIP Circus passes and tour must be scheduled by the winners at least 24 hours in advance of Circus show winner wishes to attend.
- \$50 food vouchers will be in \$5 increments. Food vendors will not give change for vouchers.
- Admission passes will be left for winners at will-call. Winner must tell S.C. State Fair representative which gate (north or south) they will enter so tickets are left at the correct will-call station.
- Food vouchers, fast passes and VIP circus passes must be picked up from the fair office inside the fairgrounds.

- Plan ahead and communicate quickly with the fair representative that contacts you. Call 803-799-3387 if additional help is required. Sponsor will not make multiple attempts to schedule plans with winners.

Failure to sign release, schedule VIP circus passes & tour by Sat., Oct. 21 or pick up the Prize before 1 pm on Sunday, Oct. 22 will result in forfeiture of the Prize.

**CONDITIONS:** All federal, state or other tax liabilities (including income taxes) arising from this Sweepstakes will be the sole responsibility of Selected Entrant. Selected Entrant may be issued an IRS Form 1099 for the ARV of any awarded Prize. All warranties are hereby disclaimed, and the Selected Entrant will accept the Prize “as is.”

The Releasees shall not be liable for: (i) late, lost, delayed, misdirected, incomplete, unreadable, inaccurate, garbled or unintelligible entries, communications or affidavits, regardless of the method of transmission; (ii) telephone system, telephone or computer hardware, software or other technical or computer malfunctions, lost connections, disconnections, delays or transmission errors; (iii) data corruption, theft, destruction, unauthorized access to or delays or transmission errors; (iii) data corruption, theft, destruction, unauthorized access to or alteration of entry or other materials; (iv) any injuries, losses or damages of

By entering this sweepstakes, Entrants acknowledge and agree that all personal information collected by Sponsor will be used for administration of the Sweepstakes. In addition, Entrants may

receive email correspondence from, or on behalf of the Sponsor or promotional partners.
